Meeting called to order at 7:00 P.M. by Henry Grace. Quorum was present.

Secretary's Report – Diana Martin - Move to accept minutes as printed in the Newswatch Newsletter. One correction was noted. Reference to construction on Tiger Bend should have stated "Jones Creek". Motion to approve was made by Mike Bass and seconded by Sandra Lambert. Motion carried.


Treasurer's Report – Mike Bass – Paid members this month is 230 with a total membership for the year of 533. The budget is in balance at this time. No questions about the report were presented.

Security Report – Tom Hirschey – Maintaining 140 hours of patrol with 4 hour administration. There were 124 stops, 84 citations, and 120 actual charges. 5 arrests were made. There were 75 vacation checks. There was a significant increase in arrests in seven months over the last twelve months due to increased patrol.

There was a resident who reported a wheel barrow stolen out of their yard during the day when a work crew left the yard for a short while. When the crew returned, the wheel barrow was gone. Residents are reminded to secure equipment or at least move from plain sight when not in use.

The school zones from Appomattox to Chattanooga are have now been revised to one continuous zone on Antioch Blvd. This should eliminate the confusion of going through two zones within a few yards of each other on the same street. Posted school zones now in affect are: 6:30 to 9:00 a.m. and 2:00 to 4:00 p.m.

The "National Night Out Against Crime" was officially observed on August 6^{th} with porch lights left on. The neighborhood celebration was held August 10^{th} at the BREC Park. There was a small


A house on Kennesaw has high grass in the front and higher grass in the back. This was reported to 311. House appears vacant.

Newswatch Report – Linda Ledoux – Deadline for articles and reports is Friday, August 16^{th} this month.

Beautification Report – The yard of the month is 17225 Terrance Ave. They will receive a \$25 gift certificate from Clegg's Nursery. Congratulations!

Old Business – Chester Welch – The Crime Prevention and Improvement District is putting a solar light on the bridge on Chadsford Ave to assist children walking to school. It has been ordered and delivered and will be installed in the next few days. Publicity will be done when installed. We are working with the lighting Manager for the City. When the project is completed, there will be a legal transfer from the Crime District to the City Parish.

New Business – There is a parking issue on Shenandoah Ave. on both sides at the entrance to the Subdivision. This will be an even bigger issue when the construction is completed and the new turn lanes are in. Tom Hirschey has requested "No Parking" signs for this area.

There has been a lot of discussion on the definition of "single family residence". Three people unrelated can live together as a single family however this changes when the number of residents goes to four.

A traffic study has been requested for Malvern Hill. There is a lot of speeding and it has become a cut through. This is anticipated to increase as the construction on Jones Creek progresses.

The landscaping of the right of way on Vicksburg owned by Greentrails is not being maintained to the same standard as other parts of Greentrails. The sidewalks and curbs are not edged or blown off. It is unsightly and sidewalks are difficult to walk through. A letter from the President will be sent to the property owner requesting that this be corrected.

The annual meeting of the Shenandoah Homeowners Association will be September 16, 2013 at 6:30 p.m. at the Jones Creek Regional Library. There will be a speaker who will discuss the "City of St. George" update. It was noted that a larger room may be needed.

An election of Board will be held at the annual meeting.

To recap the SHA Board's make-up and upcoming vacancies:

The SHA Board is comprised of ten members each serving a two year term. The members' terms are staggered so that five member's terms end each year. In addition to the members serving elected terms, the immediate past president holds a seat for one year, bringing the total Board membership to eleven.

This year Henry Grace, Sandra Lambert, Diana Martin, Kevin McNicoll and Keith Mitchell's terms expire. Each is eligible for re-election for a two-year term except Henry, who automatically returns next year as the immediate past president. Since Henry can't occupy two seats, this means FIVE people are to be elected for two-year terms If all the other four seek re-election at least one new member is needed.

Mike Bass, Tom Hirschey, and Chester Welch were elected last year to full two-year terms, as were two of the following three people: Paul Berniard, Bill Cornwell and Gretchen Nestler. The third was elected to a one-year vacancy.

The present officers on the Board will serve as the nominating committee. If anyone is interested in serving on the Board, please contact a Board officer.

The meeting was adjourned at 8:00 p.m.

SECPID has had a fully self contained and solar powered street lamp at the bridge on Chadsford between Kennesaw and Antioch. Over 30 children walk or ride across that bridge either to Shenandoah Elementary or to catch a school bus.

A dedication ceremony is planned with the SHA, SECPID, principal of Shenandoah Elementary, and member(s) of Joel Boe's office, and the EBR Department of Public Works to formally gift the \$9,500 project to the City-Parish.

The availability of grant money with which to install sidewalks in the area is being investigated.
