Kitchen fires are also more likely to cause injury, although bedroom fires remain more likely to result in fatality.

We are coming up on the holiday season, with Thanksgiving and Christmas being the days when families gather to share celebratory meals. It is worth noting that the single day of the year on which the most house fires are reported is Thanksgiving.

Follow these safety tips to cut down on kitchen fires:

- Stay in the kitchen while cooking.
- If you must leave the room, turn off the stove. If you have an electric stove, remove the pot from the burner. Electric elements continue radiating heat after they are turned off.
- Wear clothing with tight-fitting sleeves while cooking.
- If you have young children, use the stove's back burners whenever possible. Also turn pot handles to the back.
- Keep children and pets at least three away from the stove.
- Keep flammables away from your stovetop.
- Keep burners, stovetops and food prep areas clean.

National Fire Prevention Week is designated annually as the week (Sunday thru Saturday) during which October 9th falls.

On October 9, 1911 the Fire Marshals Association of North America held the first National Fire Prevention Day to commemorate the 40th anniversary of The Great Chicago Fire.

The first National Fire Prevention Week was observed by the National Fire Protection Association (NFPA) in 1922 as a way to keep the public informed about the importance of fire prevention. The first presidential proclamation of National Fire Prevention Week was by Calvin Coolidge in 1925. It has been sponsored by the NFPA ever since.

The Great Chicago Fire is one of the most famous, although not largest, fires in American history. The fire burned out of control from Sunday, October 8, to early Tuesday, October 10, 1871, killing hundreds and destroying about 3.5 square miles of downtown Chicago.

(including yard clippings and animal waste) ..., or any other substances which may be unsightly, offensive to smell or injurious to health in any private yard, lot, room or building, or on any sidewalk, street, alley, wharf, levee, public parkway, public right-of-way, or any other public place, or in any gutter or drain within the parish,

September 10, 2013



Meeting called to order at 7:00 P.M. by Henry Grace. Quorum was present.

Secretary's Report – Diana Martin - Move to accept minutes as printed in the Newswatch Newsletter. One correction was noted, the report of school zone adjustment location was incorrect. The school zones are now on Appomattox from Fort Sumter west to Chattanooga and on Antioch from Malvern Hill south past Appomattox. The Sheriff's office is reviewing some surveillance tape to assist in this investigation. Residents are reminded to lock their cars at ALL times, even under their carport.

There are new "no Parking" signs at the entrance to the subdivision on Shenandoah Avenue.

A discussion was held on the need for a "notification" sign system for residents should the need arise. It was noted that Seven Pines has a problem with run down houses and chickens.


